## Dear Prospective Vendor:

The Georgia Carolina State Fair will be held beginning Friday, October 13<sup>th</sup>, 2023 through Sunday, October 22<sup>nd</sup>, 2023.

Inside space at the fairgrounds is \$500.00 for a 10' X 10' booth - \$700.00 for a 20' X 20' booth and \$900.00 for a 10' X 30' booth (price includes liability insurance). A deposit of \$200.00 is required from all vendors no later than September 1<sup>st</sup>, 2023 and the balance due **not later than** October 1<sup>st</sup>, 2023. If deposit is not received, space location cannot be guaranteed. If full payment is not received by October 13<sup>th</sup>, 2023, set-up will not be allowed.

The Commercial Building will open one (1) hour before the Fair opens each day and will remain open until approximately midnight. **NOTE:** IF YOU CANNOT MAN YOUR BOOTH DURING ALL HOURS OF THE FAIR, DO NOT APPLY FOR SPACE. The Fair opens Monday through Friday 5:00PM until midnight; Saturday 12:00 PM until midnight and Sunday 12:00 PM until midnight. The Commercial Building will be locked and secured each night one hour after the gates close.

Set-up day will be October 13<sup>th</sup>, 2023, 8:00AM – 4:00PM. Each exhibit must not extend higher than eight (8) feet at the back. Additional decorating needs such as carpet, tables, and/or chairs, etc. must be furnished by the vendor. The Vendor is responsible for all sales tax, fees and permits necessary to conduct business in Augusta, Georgia.

All Vendors must be clear of the building by 5:00PM, Monday, October 23<sup>th</sup>, 2023.
